OFFICE ORDER

In view of rising COVID-19 cases, following measures are being implemented w.e.f. 13.01.2022 to prevent overcrowding and minimize chances of infection in the OPD/IPD areas of SGPGIMS.

OPD Services:

- 1. Online registration of new patients a must, with as few exceptions as possible.
- 2. Limit number of new patients registration to 20 per day per department
- 3. Limit number of follow up patients to 30 per day per department
- 4. Only 01 attendant is allowed with a patient to come to OPD.
- 5. Mandatory RTPCR/TruNat report from ICMR accredited lab within 72 hrs of visits, required for patient and attendant. Same to be communicated to patient at time of registration.
- 6. COVID-19 Appropriate Behaviour (CAB) is to be mandatorily followed by all patients, their relatives, and Health Care Workers (HCWs), at all times. The CAB includes:-
- a. Appropriate use of Face Masks.
- b. Maintain Physical distance as often as possible.
- c. Strict Hand Hygiene.

IPD Services:

- 1. Mandatory RTPCR/TruNat testing from ICMR accredited Laboratory done within 72 hrs, for the patients as well as of the attendant before admission and interventions to continue as before.
- 2. Restricted entry of only one patient's attendant in the wards to prevent overcrowding.
- 3. COVID-19 appropriate behaviour is to be strictly followed by all HCWs, patients and attendants.

E-OPD Services:

- 1. Shall be functional, and encouraged follow-up of patients.
- 2. Only selected patients needing urgent in person visit shall be called by e-OPD doctor to OPD.
- 3. Preference to be given to e-OPD as before both in New and Follow up OPD cases.
- 4. The same needs to be communicated to patients at the time of registration.

RCH-COVID Services:

- 1. In order to take care of the increasing work load in RCH-II/ COVID care areas, withdrawal of appropriate number of HCWs from non-covid areas will have to be undertaken.
- 2. Hence, IPD services will have to be accordingly reduced in phased manner in coming weeks.

Emergency services will continue as before with all due precautions in view of rising COVID-19.
