



Office Order

In compliance of the order of Hon'ble High Court of Judicature at Allahabad, Lucknow bench dated 13-04-2023 in writ petition writ-A 1964 of 2023 dated 13-04-2023, Governing Body in its meeting held on 23-11-2023 took decision as under:

The Governing Body directed that the hospital attendants be promoted as under:

For Promotion: Hospital Attendants/Sanitary Attendant of any grade with three years of regular service in the grade and are matriculate (10th Pass).
