Sir,

I am to state that the Postgraduate Committee of this council at its meeting held on 20.01.2009 considered the letter dated 06.12.2008 from the Dean, Sajnay Gandhi Postgraduate Institute of Medical Sciences, Lucknow with regard to recognition of M.Ch. (CTVS) qualification in respect of Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow with effect from July, 1994 instead of May, 1995 and the Committee decided as under: -

"The Postgraduate Committee observed that Dr. Abha Chandra, Professor (CTVS) at Sri Vanketeswara Institute of Medical Sciences, Tirupati vide her letter dated 18.08.2008 had informed that she was the candidate for CTVS examination held in July,1994 appeared from SGPGI, Lucknow. She requested the Council to amend its notification of M.Ch. (CTVS) qualification of SGPGI, Lucknow which was recognized with the provision when granted on or after May,1995.

The Postgraduate Committee at its meeting held on 02.09.2008 considered the letter dated 18.08.2008 from Dr. Abha Chandra and decided to obtain the clarification from the Dean, SGPGI, Lucknow regarding the year of commencement of the course.

The reply of the Director, SGPGI, Lucknow dated 03.09.2008 furnishing the details of M.Ch.(CTVS) qualification in respect of date of starting the course and date of examination of first batch was considered by the Postgraduate Committee at its meeting held on 22.09.2008 and the Postgraduate Committee directed the office to obtain clarification from the institute that though the permission was given to start the course in 1992, under what circumstances the course was started in the year 1990 and the students admitted therein.

The above decision was communicated to the college authorities vide Council letter dated 27.09.2008. In reply the Dean, SGPGI, Lucknow vide his letter dated 06.12.2008 has stated as under:-

Dean

"In this connection, it is to state that initially the Institute had started DM(Genetics), DM(Immunology), DM(Endocrinology), M.Ch.(Urology), M.Ch.(Neurosurgery) and along with M.Ch.(CVTS) courses in 1990 in anticipation with the approval of Medical Council of India. Subsequently, the inspections were held and Medical Courses of Medical had recognized these courses with effect from starting of the course.

The Medical Council of India recognized the M.Ch.(Cardiovascular and Thoracic Surgery) qualification granted by SGPGI under section IMC Act, 1956 when granted or on after

Three students namely, Dr. Amit Das, Dr. Saunak Shah and Dr. Abha Chandra, passed their final examinations in 1992, 1993 and 1994 and they were given provisional degree certificate after completion of their courses by SGPGI. Their final degrees were awarded in the first Convocation of the Institute in 1994 prior to May, 1995."

The Postgraduate Committee observed that the above stated communication of the Dean, SGPGI, Lucknow does not explain as to how the students were admitted for M.Ch.(CVTS) course prior to the date on which the LOP for starting the course was

In view of above, the Postgraduate Committee decided that the application of Dr. Abha Chandra for considering herself as a teacher couldn't be accepted. The office of the Council was directed to inform all the authorities accordingly.

Sir,

I am to state that the General Body of this council at its meeting held on 18.11.2009 considered the letter dated 17/4/2009 received from Dr. Abha Chandra, Professor (CTVS) at Sri Vanketeswara Institute of Medical Sciences, Tirupati regarding amendment in the notification of Govt. of India for recognition of M.Ch.(Cardio Vascular & Thoracic Surgery) qualification. The Council approved the following recommendations of the Postgraduate Committee:-

"The Postgraduate Committee considered the letter dated 17/4/2009 received from Dr. Abha Chandra, Professor (CTVS) at Sri Vanketeswara Institute of Medical Sciences, Tirupati and perused the record in the matter of recognition of M.Ch. .(Cardio Vascular & Thoracic Surgery) qualification awarded by Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow and observed that no permission of Medical Council of India was required u/s 10A of the IMC Act, 1956 in the year 1990 when the course had commenced as this section was inserted only w.e.f. 1993. It was further observed that the degree awarded by Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow in the subject of M.Ch. .(Cardio Vascular & Thoracic Surgery) has already been recognised by the Council when granted on or after May, 1995. It was observed that in similar matter with regard to recognition of the qualification for the batches admitted prior to the year specified in the notification, the General Body of the Council from time to time had decided to consider the qualifications obtained prior to such years a recognized qualification.

In view of above and after due deliberations, the Postgraduate Committee decided to accept the request of Dr. Abha Chandra, Dr. Amit Das and Dr. Saunak Shah who have received their degrees of M.Ch.(Cardio Vascular & Thoracic Surgery) prior to 1995 as having recongised postgraduate degree."

The Council further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

Failure to seek timely renewal of recognition as required in sub-cluase-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

You are therefore requested to notify the above qualification from 1994 instead of May 1995.
