I am directed to state that the Board of Governors considered the Council Assessor's Report(s) (21st & 22nd June, 2019) on the standard of examination and other teaching facilities for Renewal of Recognition of DM(Medical Gastroenterology) qualification for 6 seats in respect of students being trained at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow granted by Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Statutory Autonomous), Lucknow and Committee decided as under:-

"The Board of Governors considered the Council Assessor's Report (21st & 22nd June, 2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that DM(Medical Gastroenterology) qualification for 6 seats granted by Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Statutory Autonomous), Lucknow in respect of students being trained at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
