Sub: Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Deemed University), Lucknow - Recognition of MD(Nuclear Medicine) qualification against increased intake from 01 to 02 seats in respect of students being trained at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow.

I am to state that the General Body of this council at its meeting held on 30/03/2016 considered the Council Assessor's report (May, 2015) on the standard of examination and other teaching facilities available at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow for purpose of Recognition of MD(Nuclear Medicine) qualification against increased intake from 01 to 02 seats granted by Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Deemed University), Lucknow.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Nuclear Medicine) qualification against increased intake from 01 to 02 seats granted by Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Deemed University), Lucknow in respect of students being trained at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow be recognized and included in the 1st Schedule to the U.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
