### Walk in Interview for Faculty appointment on contract basis for 89 days

### Essential Qualification & Experience:

- A medical qualification included in the first or second schedule or part II of the third schedule of the Indian Medical Council Act, 1956. Persons possessing qualifications included in part II of the third schedule of the said Act shall also fulfill the conditions specified in sub-section (3) of the section 13 of the said Act.
- A postgraduate qualification recognized by the Board of Governors in supersession of National Medical Commission or equivalent thereto (i.e. if a person with postgraduate medical qualifications awarded in the United States of America, United Kingdom, Canada, Australia or New Zealand desires to take up a teaching appointment, his/her qualification can be considered as equivalent qualification with MD/MS/DM/MCh as the case may be, for the post of Assistant Professor in respective departments in medical colleges in India as per fulfillment of Foreign Postgraduate Qualifications for equivalence norms laid down by NMC from time to time), as indicated in the table below is required.

**Diplomate National Board (DNB) /Doctorate of National Board (DrNB)** shall be treated as equivalent to MD qualifications of the respective broad/super-specialties as per NMC Notification issued from time to time<sup>#</sup>.

#### **# For Determination of equivalence of the qualification of DNB/DrNB with MD/MS and DM/MCh.**

The Diplomate of National Board (DNB/DrNB) in broad specialty and in super specialty qualification when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds by the National Board of Examinations shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/MCh) postgraduate qualification. For the purposes of equivalence in teaching, persons holding a Diplomate of National Board qualification in broad specialty obtained from medical institutions with a bed strength of less than 500 shall be required to complete an additional one-year senior residency in a recognised medical institution in the relevant specialty. Certificate from concerned Hospital where DNB has been done should be provided by the candidate.

Post DNB/MD/MS a 3 years DrNB course and in case of direct entry at MBBS a 6 year DrNB Programme has to be completed from a recognized institute/medical college from NBEMS. The candidate should be registered for DrNB training in respective course and also should have passed the final exit examination leading to the award of DNB/DrNB qualification. Certificate from the recognized commission should be provided by the candidate as on last date for submission of application.



### III.b. Additional requirements are as follows:

For Super specialty departments the candidates must have completed the Basic Course in Biomedical Research (BCBR) from a recognized medical institution designated by the Commission.

**PUBLICATIONS:** As per latest NMC/MCI guidelines.

**FIXED HONORARIUM:** Rs.1, 20,000=00 per month.

**UPPER AGE LIMIT:** 50 years as on 23.12.2025 or as per Government regulations in this regard, in force from time to time.

**UNDERTAKING:** Before appointment, every candidate shall have to submit an undertaking that he/she would not claim continuation of appointment after 89 days.

### GENERAL CONDITIONS:
