# 4. TERMS AND CONDITIONS FOR THE CONTRACTUAL DEPLOYMENT FOR THE ABOVE SAID POSITIONS ARE AS UNDER:-

**1.** How to Apply: Those interested should apply with their bio data, contact details and names of three referees under whom the candidate has trained or worked for, as per template attached. We may speak to your referees.

- 2. The engagement is purely on Contract Basis (fixed wages) for a period of six (06) months. If the contract is not extended further, the same will lapse automatically without assigning any reason. The contractual deployment can also be terminated any time, on either side, by giving one month's notice within the course of six (06) months. Since it is a contractual position, each tenure will be for 6 months on satisfactory performance, extension will be given for 6 months each time with a cooling period of 3 days.
- **3.** The worker will perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional remuneration will be admissible in case of all such assignments.
- **4.** The worker will not be entitled to any benefit like Provident Fund, Leave Travel concession, Medical claim, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc, or any other benefits available to the Government Servants appointed on regular basis. No TA/DA will be paid for attending the interview.
- **5.** The contractual worker will not be granted any claim or right for regular appointment to any post of SGPGIMS, Lucknow. The above posts are filled up purely on temporary basis, co-terminus with the project & the candidate will have no right to claim for permanent Employment under NCDIR/NCRP/ICMR or continuation of his/her services in any other project.
- **6.** The worker will shall be whole time worker of the SGPGIMS and must not accept any other assignment, paid or otherwise and must not engage himself/herself in a private practice of any kind during the duration of contract.
- 7. If any declaration given or information furnished by him/her turns out to be false or if he/she is found to have wilfully suppressed any material information he/she will be liable for removal from contractual deployment and also such other action as the Institute may deem necessary.
- **8.** The contractual worker will not be entitled to avail any allowances/facilities being extended to the adhoc/regular/permanent faculty/staff of the SGPGIMS, Lucknow.

It is being emphatically brought to the notice of both prospective applicants & subsequent contractual workers (who will report to work under HBCR, NCDIR after due selection process) for the completely temporary positions of Statistician, Social Worker and Data Entry Operator under NCDIR, Bengaluru that the regularity of release of Grants in Aid (through which monthly wages are paid) by Indian Council of Medical Research, Ministry of Health and Family Welfare, Government of India can't be ensured & there may be disruption in the regularity/continuity of payment of wages which solely depends on decision as appropriate; by NCDIR, Bengaluru. #### 10. Procedure for Selection:

The following procedure shall be adopted for short-listing of candidates for an in-person interview.

(a) There will be a preliminary screening of the eligibility and those eligible, will be required to come for a multiple choice question test in English in the areas of social work, basic statistics, word processing, excel, english and basic mathematics. The MCQ test will be of one hour duration with 60 questions having one stem and four possible responses out of which a candidate will be required to indicate the best or most appropriate response.

Each correct response will fetch one mark while each incorrect response will result in a deduction of 1/4<sup>th</sup> mark.

(b) The following day for each advertised post the top five ranking candidates will be informed via email and called for an interview. In the event of a tie all candidates who tie for the same rank shall be called. During the interview a copy of the CV will be taken and all original certificates related to qualifications and age will need to be seen in original.
