9. Procedure for Selection:

The following procedure shall be adopted for short-listing of candidates for an in-person interview.

- (a) There will be a preliminary screening of the eligibility and those eligible, will be required to come for a multiple choice question test in English in the areas of social work, basic statistics, word processing, excel and basic mathematics. The MCQ test will be of one hour duration with 60 questions having one stem and four possible responses out of which a candidate will be required to indicate the best or most appropriate response. Each correct response will fetch one mark while each incorrect response will result in a deduction of 1/4th mark.
- (b) The following day for each advertised post the top five ranking candidates will be informed via email and called for an interview. In the event of a tie all candidates who tie for the same rank shall be called. During the interview a copy of the CV will be taken and all original certificates related to qualifications and age will need to be seen in original.
