

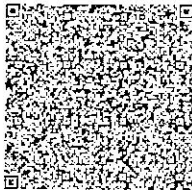

1. In this Agreement words and expressions shall have the same

2. **Performance Security Deposit:**

(1) The Service Provider shall submit security deposit @ 5% of the

provider dated 19.05.2021.

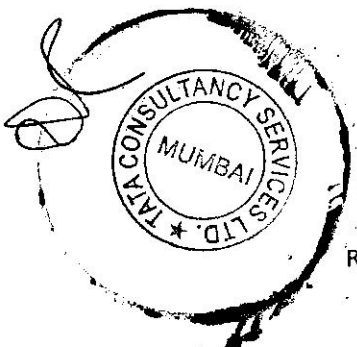

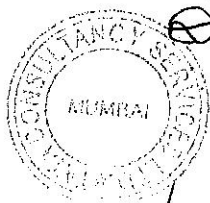
