For the two complaints received, the meetings were held on the following dates and the meetings were resolved.


One complaint has been received and the first meeting for the issue was held on 19th March 2024. The committee is looking into the matter to solve the issue.

Respected Ma'am,

We students of B.Sc. Nursing 1st year are writing to inform you that we are being mentally harassed regularly in the hostel. We are being continuously harassed by our seniors of 2nd year. We have been called thrice late night in an isolated room for the purpose of telling rules of hostel but instead they indulge us in unusual talks like:

- Seniors like [redacted], [redacted], [redacted] & many others. We are adherent to wish the seniors in college but not outside the college but we are always compulsated to wish the senior every moment we see them, especially when we don't get response of that from our seniors & they make odd faces & passes comments upon our clothings & behaviour. On the other hand they themselves don't wish their seniors.
- Eventually, when are called they always comment upon our upbringing & what kind of morals we have been given by our parents.
- Whenever we complaint about mess food to the owner. Our seniors are having problem with that too. If they are eating the same food, why are we complaining about it. But, I don't understand why I can't complain if I am paying for the food & not satisfied.
- Mehak Srivastava, our senior of 2nd year, once threatened the whole 1st year by saying:

"उठवा लेगे पता भी नहीं चलेंगा, कहीं जाओगा,
क्योंकि मेरे पापा कमिश्नर हैं।"

- Our seniors of 2nd year have problem with our bonding with seniors of 2nd year, 3rd & 4th year & ask us not to interact with them.

We request you to take quick required actions against these people as soon as possible. It would be very grateful of yours if required have taken place.

Subsequent to the remarks by Executive registrar on the personal file of Mr [REDACTED] Yr B SC Nursing Student, CON-SGPGIMS and Office order no PGI/CON/702/2017 dated 26.04.2017 from Dr Rajesh Harshwardhan, Nodal Officer, CON-SGPGIMS, a meeting was held in the office of Dr Khaliqur Rahman, Enquiry Officer ([REDACTED] ase) and Associate Professor, Department of Hematology at 12:00 noon on 29.04.2017.

Mrs Shamim Rizvi (Presenting officer and AAO, CON –SGPGIMS) presented the case. Both, Mr [REDACTED] Shukla and [REDACTED] Javid were called for cross examination and the proceeding was voice recorded. Mr [REDACTED] Shukla accepted his misconduct and was extremely sorry for his behavior and activities in the past. He has promised that he will not repeat it again and if found repeated, stern disciplinary actions should be taken against him. (Letter attached)

[REDACTED] on the other hand has reported that Mr Neeraj Shukla is continuing with his misconduct and passes bad comments to her regularly, even after the issue of warning letter. She told that, she did not report it in writing as she was afraid of the warning letter that was issued to her as well. [REDACTED] repeatedly said that [REDACTED] is following her and continuing his misconduct both inside as well as outside the campus. (Audio recording is attached).

It is felt that, though [REDACTED] is sorry for his behaviors and activity in past and promised not to repeat it in future, he does not really mean it. In spite of warning letters and several counseling, he is continuing with his misconduct and harasses [REDACTED]. It is recommended that he should be suspended from his classes for two weeks.

Both [REDACTED] & [REDACTED] Ms. Mehvish Javed student of B.Sc. Nursing 2nd year were called for cross examination and after hearing their points they were asked to submit their written statement about the whole incident.

Ms. [REDACTED] reported in her written statement that Mr. Neeraj Shukla is continuously following with his misconduct and passing abusive comments regularly even inside as well as outside the campus. She has also reported that on 30.11.2017 he forced her to take a gift and on refusal, he threw it on her face. She further stated that he has been trying to talk her and told that he will kill her and do what nobody did.

Mr. [REDACTED] has reported in his written statement that he was threatened and warned by Mr. Sameer Pandey (4th year student now he is pass out student) not to talk to Ms. Mehvish Javed otherwise he will destroy his career and after that Ms. Mehivish Javed has lodged several complaint against him. These complaints has led him sever tension. He has further alleged that Ms. Mehivsh Javed has been continuously defamed him on several occasions.

About the said incident, on 30.11.2017 he has stated in his written statement that his father had advised him to give a gift to her on her birthday to sort out all differences between them. So he has asked Ms. [REDACTED] Nursing student to handover the gift to Ms. [REDACTED] on behalf of him which was refused by Ms. Mehvish Javed.

Enquiry Committee after perusing the complaint & written statement of Mr. Neeraj Shukla and Ms. Mehvish Javed decided to seek comments of the following :-

1. A letter may be sent to his father for verification of written statement given by Mr. Neeraj Shukla on 11.01.2018 before enquiry committee.
2. A letter be issued to Ms. Versha Dwivedi B.Sc. Nursing 2nd student, to submit a written statement wether the gift was given by Mr. Neeraj Shukla to hand over to Ms. Mehivsh Javed B.Sc. Nursing 2nd year student on behalf of him on the occasion of her Birthday on 30.11.2017.
3. A letter be issued to Mr. Chheda Lal, Security Guard and Mrs. Ram Dayi Sr. Attendant, who were posted on evening duty on 30.11.2017, to submit their written statement about the incident.


Committee further decided to obtain the comments to all concerned as stated above and organize a meeting of the Enquiry Committee to further consider the facts and then decide the case accordingly


